| <b>Individual</b>                              | Persons involved in and committed to the goals of community-based economic development.   |
| <b>Supporting Organization</b>                 | Nonprofit organizations or other associations that, while not engaging directly in CED work, share CEDAM 's goals. Units of government are also included in this category.  |
| <b>Sustaining Organization</b>                 | For-profit corporations that either share our vision or partner with our members.   |
